SECTION IV HEALTH INFORMATION

EYE CONTACT: This product is presumed to be moderately irritating to the eyes. Exposure may cause corneal injury. Product vapors and/or mists may also be irritating to the eyes.

SECTION V EMERGENCY AND FIRST AID PROCEDURES

EYE CONTACT: If irritation or redness develops, move victim away from exposure source and into fresh air. Flush eyes with water for fifteen minutes. If symptoms persist, seek medical attention.

ADDITIONAL PRECAUTIONS
